Governing Document

The Society was registered as a SCIO in June 2012 and is governed by the Constitution from that date. The original constitution of the former organisation known as "The Jubilo Society' was dated 10 October 1982 with an amendment dated 3 March 1997. There was a further amendment of the constitution to take account of the Data Protection Act 2018, in 2019. Further minor amendments were made in 2023.

Organisational Structure

The operation of the trust is the sole responsibility of the Trustees who meet regularly during the year. The receipt and disbursement of funds is carried out by the Treasurer who is also a Trustee.

Relationship with another Body

The Society has no fixed relationship with another charity but collaborates with other musical organisations as performance and learning opportunities arise. The Society is a member of Making Music, which provides us with insurance and advice, and support for planning and organizing our administration and activities.

Appointment of Trustees

The Trustees are the members of committee. Committee members are elected or re- elected by the general membership annually at the AGM.

Objects

The objects of the SCIO are articulated in the Constitution as follows: "to promote, improve, develop and maintain appreciation of, and education in, the art and science of music and drama in all its aspects by the promotion of and/or participation in, public or private concerts, recitals and performances and by such other ways as the Society through its officers may determine".

Main Activities during the Period

The Choir, which is the focus of the Society, met weekly to rehearse for the season's concert programme from September 2023 to May 2024 at St Columba's church, Blackhall. Our Musical Director, Libby Crabtree, had announced that after 7 years in post she would be leaving us in December after our planned Christmas concert. So while she continued to conduct rehearsals for the concert over the autumn, we completed the process of recruiting a new Musical Director to take over in January 2024. We appointed Paul Gudgin, who conducted our rehearsals between January and May 2024, in preparation for our Spring Concert of Baroque music in April and a fund-raising Come-and-Sing concert at the start of June.

In the past session, the choir has chosen to support the charity BrainPower, which was set up by BBC journalist Glenn Campbell, himself diagnosed with a brain tumour in the summer of

2023. He is raising money through BrainPower to help the charity Brain Tumour Research establish its fifth UK Research Centre of Excellence in Scotland, in collaboration with Glasgow and Edinburgh universities and the Beatson West of Scotland cancer centre. Over the past session, from the Christmas Concert, the Spring Concert and our Come and Sing, we have succeeded in raising a total of £2,245 for BrainPower.

Also during this session, with a view to tidying up our administration and improving our efficiency, security and online presence, we have set up a new Jubilo website on the Making Music platform. The website is now up and running, supporting the Committee's communication with our current Members, our publicity for events and our outreach to potential new members.

Achievements and Performance

Summary of the main achievements of the Charity during the financial period

This season we have been able to perform our customary Christmas and Spring concerts, and in addition organise a Come-and-Sing fund-raising event. The Christmas Concert, Libby's final event, respected the choir's traditions while at the same time extending our seasonal repertoire and skills. The result proved a truly exhilarating evening for the singers, orchestra and audience. For the Spring Concert of Baroque music, Paul in his turn offered us a really challenging programme whose success was a tribute to his skill and enthusiasm and to the choir's determination to learn and perform the music to a high standard. Our final event of the season was a Come-and-Sing Haydn's Nelson Mass, planned to raise money for BrainPower, this year's charity, and also to raise awareness of Jubilo with a view to recruiting new members. Feedback from singers and audience suggested that it was enjoyed by both members and non-members of Jubilo and we raised over £1000 for BrainPower on the day.

Financial Review

Brief statement of the charity's policy on reserves

The Society continues its prudent policy in budgeting and financial control, both of which are subject to regular review. The Trustees intend to maintain reserves which are adequate to maximise the present and future capabilities of the Choir. At the Annual General Meeting on 22 October 2023 members considered that the reserves of circa £17,000 were adequate for the Society's purposes and accordingly no changes were made to members' subscriptions or concert ticket prices. The meeting also agreed that for the 2023-24 season members would normally be expected to purchase 3 rather than 5 tickets for each concert, for onward re-sale at their discretion. Although these policies resulted in rather lower ticket revenue, they were expected to achieve a break-even financial position overall during 2023-24 which has largely been achieved, with only a small deficit. Revenue sources will be reviewed again at the Annual General Meeting on 20 October 2024 in the light of anticipated increases in costs.

Financial Results

The Society made an overall deficit of £238.

Donated Facilities & Services

The Society does not depend on any material facilities or services on a regular basis but is grateful to all who give of their talents and experience voluntarily.
