Governing Document

The Society was registered as a SCIO in June 2012 and is governed by the Constitution from that date. The original constitution of the former organisation known as "The Jubilo Society' was dated 10 October 1982 with an amendment dated 3 March 1997. There was a further amendment of the constitution to take account of the Data Protection Act 2018, in 2019. Further minor amendments were made in 2023 and 2024.

Organisational Structure

The operation of the trust is the sole responsibility of the Trustees who meet regularly during the year. The receipt and disbursement of funds is carried out by the Treasurer who is also a Trustee.

Relationship with another Body

The Society has no fixed relationship with another charity but collaborates with other musical organisations as performance and learning opportunities arise. The Society is a member of Making Music, which provides us with insurance and advice, and support for planning and organizing our administration and activities.

Appointment of Trustees

The Trustees are the members of committee. Committee members are elected or re- elected by the general membership annually at the AGM.

Objects

The objects of the SCIO are articulated in the Constitution as follows: "to promote, improve, develop and maintain appreciation of, and education in, the art and science of music and drama in all its aspects by the promotion of and/or participation in, public or private concerts, recitals and performances and by such other ways as the Society through its officers may determine".

Main Activities during the Period

The choir, which is the focus of the society, met weekly in St Columba's Church, Blackhall from September 2024 to May 2025 to rehearse for the season's concert programme. Our musical director was Paul Gudgin, who took over the role in January 2024.

In the past session, the choir has continued to support the charity Brain Power, which was set up by journalist Glenn Campbell after he was diagnosed with a brain tumour in 2023. He is raising money to support the charity Brain Tumour Research in establishing its fifth UK Research Centre of Excellence in Scotland, in collaboration with Glasgow and Edinburgh Universities and also the Beatson West of Scotland Cancer Centre. Over the past session we have raised around £2,800 for the charity from the Christmas concert, the spring concert and our Come and Sing.

Achievements and performances during the financial period

This season we have performed our usual Christmas and spring concerts and have organised a Come and Sing fundraising event. The Christmas concert saw us revisiting some well-known carols and learning some new ones, and we thoroughly enjoyed performing to an appreciative audience. For the spring concert, Paul introduced us to a novel – for Jubilo - programme of jazz pieces: Bernstein's *Chichester Psalms*, familiar to some, but not many of us; and Ellington's *Sacred Concert*, new to nearly all. We had the exhilarating experience of performing with a big band on the concert day. Unfortunately, however, we did make a loss on this concert for various reasons – mainly because of a hike in the prices charged by St Cuthbert's, our venue, and the cost of the band. We have made plans to reduce our expenses for next year and to increase our revenue.

Our final event of the season was a very successful Come and Sing of Fauré's *Requiem* at St Columba's. All the proceeds went to Brain Power, and we also hope to have raised the profile of the choir in the local area and to have attracted some new members.

Financial Review

Brief statement of the charity's policy on reserves

The Trustees intend to maintain reserves which are at least sufficient to cover the overhead costs of the choir apart from the concerts – including hire of rehearsal hall, payments for musical direction and accompaniment at rehearsals, and administrative costs. Given that these overhead costs total £10,000 - £11,000 at current prices, the reserve of £12,597 at 31st July 2025 is considered adequate notwithstanding the deficit recorded in 2024-25. However, the Trustees would not wish the reserve to fall any lower

and will be seeking to achieve a surplus in 2025-26 in order to restore more financial stability and provide flexibility in funding concerts. At the AGM on 20 October 2024 the choir approved an increase in all adult ticket prices to £15 and agreed that members should each buy 4 adult tickets for each concert, but the increase in income did not cover the year's increased costs. At the next AGM on 19 October 2025, ticketing arrangements and members' subscriptions will again be reviewed and proposals for increasing income will be considered.

Financial Results

The Society made an overall deficit of £4,658.


Donated Facilities & Services
